

Cookie Policy

(Article 13 UE Regulation 679/2016 - "GDPR")

This page describes the management of the website www.inspiritu.com owned by Tenuta di Paternostro with reference to the processing of personal data of users who consult it.

This information is provided pursuant to Article 13 of UE Regulation 679/2016 and of the Italian Privacy Code, as amended by Legislative Decree n. 101/2018, to those who interact with the services of Tenuta di Paternostro, made available through this website.

The information refers only to this website and does not extend to others, possibly consulted by the user via hyperlink (*link*).

Data controller

Following consultation of this website, data relating to identified or identifiable persons may be processed.

The Data Controller of their processing is Tenuta di Paternostro, with registered office in Rome, _____.

Place of data processing

Data processing related to the web services offered mainly take place on the servers hosting the website; the equipment is located in its processing centres located in Europe.

Categories of data processed, purpose of treatment, legal basis and conservations times

Navigation data

The computer systems and software procedures used to operate this website acquire, during their normal operation, some personal data which are processed in the use of internet communication protocols. These are information (IP addresses) that are not collected to be associated with identified data subjects but which, because of their nature, could allow users to be identified through processing and associating with data held by third parties. These data are processed for the sole purpose of obtaining anonymous statistical information on the use of the website and to control its correct functioning; moreover, they could be processed if deemed necessary or at the request of public authorities. The condition that makes the processing lawful (legal basis) is the legitimate interest of the Data Controller.

Cookies

We do not use cookies to transmit personal information. This website uses session cookies. The use of session cookies (which are not stored permanently on the user's computer and disappear when the browser is closed) is strictly limited to the transmission of session identifiers (consisting of random numbers generated by the server) necessary to allow safe and efficient exploration of the website. These cookies avoid the use of other technologies that could compromise the privacy of users' browsing and do not allow the acquisition of personal identification data. The data session cookies are stored as long as the user visits the website. The condition that makes the processing lawful (legal basis) is the legitimate interest of the data controller.

Subjects authorized to data processing

The data may be processed by employees and collaborators responsible for the pursuit of the aforementioned purposes, which have been expressly authorized to process and have received appropriate operating instructions.

Categories of subjects to whom data can be communicated

The data may be disclosed to parties operating as other Data Controllers or processed on behalf of Tenuta di Paternostro, by third parties appointed as data processors, to whom appropriate operational instructions are given, which perform tasks of a technical and organizational nature on behalf of the Data Controller.

Data retention period

The data are kept for the entire browsing activity on the website and for further 12 months for statistical purposes.

Rights of the interested party

According to UE Regulation 679/2016 and the Italian Privacy Code, as amended by Legislative Decree no. 101/2018, data subjects have the right to apply to the Data Controller to access personal data, to correct or delete them, to limit the processing of his/her personal data, to object to their processing, to achieve data portability. Finally, the data subject has the right to lodge a complaint with the Data Protection Authority as well as to use other means of protection provided for by the applicable legislation.
